

Privacy Statement

The Trademark, Patents and Designs Registry is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to The Trademark, Patents and Designs Registry Web site and governs data collection and usage. By using The Trademark, Patents and Designs Registry website, you consent to the data practices described in this statement.

Collection of your Personal Information

The Trademark, Patents and Designs Registry collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. The Trademark, Patents and Designs Registry also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by The Trademark, Patents and Designs Registry. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. This information is used by The Trademark, Patents and Designs Registry for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of The Trademark, Patents and Designs Registry Web site.

Use of your Personal Information

The Trademark, Patents and Designs Registry collects and uses your personal information to operate the Trademark, Patents and Designs Registry Web site and deliver the services you have requested. In addition, the Trademark, Patents and Designs Registry may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to the Trademark, Patents and Designs Registry, and they are required to maintain the confidentiality of your information.

The Trademark, Patents and Designs Registry does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

The Trademark, Patents and Designs Registry keeps track of the Web sites and pages our customers visit within the Trademark, Patents and Designs Registry, in order to determine what The Trademark, Patents and Designs Registry services are the most popular. This data is used to deliver customized content and advertising within the Trademark, Patents and Designs Registry to customers whose behavior indicates that they are interested in a particular subject area.

Use of Cookies
